Eight teams from the Department of Justice Office of the Inspector General (OIG) were honored for their accomplishments today at the 17<sup>th</sup> annual inspector general community awards ceremony.

The Council of the Inspectors General on Integrity and Efficiency (CIGIE) awarded this year's Alexander Hamilton Award -- the highest honor bestowed by the inspector general community -- to the **DOJ OIG Witness Security (WitSec) Program Review Team** "in recognition of the team's significant contributions to national security and public safety during an audit of the Department of Justice's handling of known or suspected terrorists admitted into the Federal Witness Security Program." The award highlights achievements in improving the integrity, efficiency, and effectiveness of Executive Branch agency operations.

This is the second consecutive year a team from DOJ OIG has won the Alexander Hamilton Award. The WitSec team included DOJ OIG members from the San Francisco Regional Audit Office, the Chicago Regional Audit Office, and Audit Headquarters in Washington. CIGIE also awarded the Barry R. Snyder Joint Award to the **Boston Marathon Bombing Team**, consisting of OIG personnel from the Offices of the Inspector General for the Intelligence Community, Central Intelligence Agency, Department of Justice, and Department of Homeland Security, in recognition of their collaborative work in conducting a joint independent review of the U.S. Government's sharing and handling of information leading up to the Boston Marathon Bombing." In addition, the 2014 Sentner Award for Dedication and Courage was awarded to the Special Inspector General for Afghanistan Reconstruction's Jeffrey Millslagle "in recognition of his courage, uncommon selflessness, and dedication to duty during an insurgency attack on the Herat Consulate in Afghanistan in September 2013." The award recognizes an individual or team demonstrating uncommon dedication and courage in the face of adversity and was named for William "Buddy" Sentner, III, a Special Agent at DOJ OIG who was fatally shot in the line of duty in 2006.

A total of more than 85 individuals and groups were recognized by CIGIE at the awards ceremony today at the Ronald Reagan Building Amphitheatre in Washington, D.C. James B. Comey, Director of the Federal Bureau of Investigation, gave the keynote address.
