

## FY 2012 OIG Recovery Act Plan Overview

<b>OIG Name:</b>	U.S. Department of Justice, Office of the Inspector General
<b>OIG Broad Recovery Act Goals:</b>	The OIG's Recovery Act goals are tied to OMB's accountability objectives for the Recovery Act. We are assessing the extent to which: (1) funds are awarded and distributed in a prompt, fair, and reasonable manner; (2) the recipients and uses of all funds are transparent to the public, and the public benefits of these funds are reported clearly, accurately, and in a timely manner; (3) funds are used for authorized purposes and potential for fraud, waste, error, and abuse is mitigated; (4) projects funded under the Act avoid unnecessary delays and cost overruns; and (5) program goals are achieved, including specific program outcomes and improved results on broader economic indicators.
<b>OIG Broad Training and Outreach Recovery Act Goals:</b>	For state and local grant administering agencies, our Recovery Act training goal is to provide grant fraud awareness training to state and local agencies as requested by those agencies or by the Department's granting agencies. We have conducted in-person briefings for 43 State Administering Agencies to explain the OIG's Recovery Act role and oversight assistance activities. In-person and telephone briefings with large local administering agencies are continuing.
<b>OIG Recovery Act Risk Assessment Process:</b>	The OIG's Recovery Act risk assessment process evolved as the funded programs were implemented. At the start of the programs, we surveyed experienced OIG staff and reviewed prior reports to identify and summarize known grants management issues. Based on this effort, we developed and widely distributed a document titled Improving the Grants Management Process. We have performed five internal audits and an evaluation of Recovery Act programs at the Department level to assess the risk associated with grants management. We have completed 5 audits of Recovery Act grant recipients selected based on various risk-based criteria since our last update to this plan in November 2011, bringing the total completed audits to 23. We have 23 other such audits in progress. We maintain a process to assess Single Audit Act audit reports for indicators of risk to DOJ grant funds. We are utilizing Recovery Accountability and Transparency Resources to assess third-party data sources for indicators of risk to DOJ grantees.
